- ☐ I have submitted copies of pet vaccinations, divorce decrees and/or death certificates if indicated. If not, I have explained in the comment section below.
- ☐ I have submitted a writer biography of each Petitioner.
- ☐ I have verified all of the allegations in the petition for adoption.
- ☐ I have submitted additional information to assist the Court in determining if there has been compliance with the provisions of the Alabama Adoption Code.
