

Mobile County's Circuit Court Clerk and Absentee Election Manager, Jo Jo Schwarzauer, and Mobile County's Judge of Probate and Chief Election Officer, Don Davis, announced that Mobile County's Absentee Election Manager's Office will be open on the following dates between 9:00 a.m. and 1:00 p.m. to offer Mobile County citizens additional opportunities to submit an absentee ballot application and/or obtain absentee election materials prior to the 2020 General Election:

Saturday, October 10, 2020  
Saturday, October 17, 2020  
Saturday, October 24, 2020

The Absentee Election Manager's Office is located on the first floor of the Mobile County Government Center Annex, 151 Government Street, Mobile, Alabama. The CDC's COVID-19 pandemic guidelines are being utilized in the Annex. Voters are requested to wear a face mask while inside the Annex, although wearing a mask is not mandated in order for a citizen to vote.

Additionally, the Absentee Election Manager's Office will be open on Saturday, October 31, 2020, from 9:00 a.m. until 1:00 p.m. for voters to hand deliver absentee ballots to the office.

The absentee ballot application form can be downloaded from the Mobile County Probate Court's web site [[www.probate.mobilecountyal.gov](http://www.probate.mobilecountyal.gov)], printed out and completed by a voter prior to the voter coming to the Annex to vote absentee.
